ASSISTANT COMMISSIONER'S REPORT:

1. General:

- Urban Forest Master Plan Review
 - Update Second Draft available at <u>Trees in the City Right Tree, Right Place | City of Worcester, MA (worcesterma.gov)</u>
 - Assistant Commissioner Antonelli explained that once the Master Plan is approved by the Parks & Recreation Commission it would go to go to City Council for review. The Council will decide if it would go to either to a Public Works or Parks item, also there will be hearing and then it will go back to council, therefore both the Sub-Committee and Council will vote on it.
 - Commissioner Winbourne opened up the meeting for Commission for comments on the plan, she started her suggestion:
 - She suggested some simple edits on pages 26 she said that there were inconsistencies that would be easy to fix.
 - On page 26 & 75 in the vision statement the words "continue to" needs to be removed.
 - She suggested creating a list of changes to give to Davey Resource.
 - Commissioner Karoway-Waterhouse:
 - Stated there were bad graphics and low resolution on pages 30 & 33.
 - Timelines need to be updated on the implementation section starts on page 91.
 - Color consistency.
 - Suggested a better quote at the beginning Page 14 section 1.
 - Commissioner Wobbe had questions:
 - On page 20 there a color in the map that is not in the key, and vice versa a color in the key that was not on the map. This needs to be corrected.

- On page 40, there's a graphic that talks about tons, it defines the tons as 2200 pounds which is a metric ton not a US ton. Clarify and specify when talking about tons and use the correct conversion.
- On page 27 is missing planting and it is important to add planting.
- On page 59 remove figure 16 and the information, it is a duplication.
- On Page 39 change the language to of plant tree to young tree training.
- Evelyn Hurwitz as well as Deby Cary both spoke in favor of the Master Plan and were thankful to the Commission and the City of Worcester.
- Phillys was online and she congratulated the Commission for their due diligence.
- Commissioner Winbourne thanked Assistant Commissioner Antonelli as well as Forestry Supervisor Brian Breveleri.
- Commissioner Winbourne made a motion to approve the Urban Forestry Master Plan with the condition that the changes mentioned above are made before moving forward. Second by Commissioner Elton. All were in favor. Motion was approved 4 – 0.

- Planting
 - Spring 2024 Planting Not done yet, planted 120 trees to date.
 - Assistant Commissioner explained that there are many people who do not want trees in front of
 their houses and that the Forestry Division as well as the office staff is getting the brunt of it from
 the public who are not happy. He later added that this is one of the reasons he would like the
 Commission to start attending neighborhood meetings educating people on the importance of
 trees
 - Commissioner Karoway-Waterhouse suggested educating people on the benefits of tree planting at neighborhood meetings, and maybe getting some outreach materials that can get handed out to the public.
 - Councilor Pacillo asked what the process is to notify people that a tree is going to be planted in front of the house.
 - Assistant Commissioner Antonelli said that the majority of the trees planted to date had been requested. Other trees planted were streets that were resurfaced and wherever there were open tree pits.
 - Councilor Pacillo said if the city usually sends out a letter notifying people when they resurface streets, she suggested maybe they can add "potential a tree can be planted" as part of that notice.
 - Assistant Commissioner Antonelli explained that they are working logistics with Engineering as well as Transportation and Mobility.
 - Commissioner Karoway-Waterhouse explained that the Commission voted to move Worcester
 into a pro-active approach rather than by request only regardless of whether or not the resident
 wants the tree or knows that it's coming, she said they believe that's what needs to be done
 environmentally for the best Worcester possible.
 - Mr. Breveleri went over the species being used this year, shown below. He stated he should have
 a final list of planting list with species and locations by the end of July.
 - Hybrids of Elm
 - Kentucky Coffee Tree
 - Red Oak
 - Quercus (decreasing)
 - Red Maple (very small percentage)
 - London Plane

- Commissioner Elton suggested to use the Worcester alerts to notify or give people alerts of tree plantings.
- Assistant Commissioner Antonelli said he could look into it, and check with Emergency Management, and will see what other options there are.
- Assistant Commissioner Antonelli spoke about the map from DCR Greening the Gateway Cities
 Program in Worcester, it shows the area that they are working in doing some tree planting.
- Commissioner Winbourne suggested having a plan/map of the areas where there will be tree
 planting where people are not asking for a tree, and that the Commission can work with the
 Community groups to try to find tree advocates.
- Assistant Commissioner Antonelli agreed that something like that can be done around the beginning of the calendar year.
- There were different suggestions on how to get the word out such as the T&G or through Worcester Public Schools, Neighborhood Centers, Registry system for rental properties.
- Debby Cary asked if there's a map of what's planted and where and can that shared.
- Mr. Breveleri answered yes that is the hope that the platform being using through Davey Resource, staff goes out and then plants them at each specific address and who planted them they are also adding to that future a watering component. The idea is to get the map to GIS to present a map with that.
- Commissioner Elton suggested to look at the New York City Parks Forestry website, it looks like
 they use Davey Resource Group and it's outstanding. It has the ecological benefits, the DBH of the
 tree, when it was planted, how much storm water is collecting, how much carbon is sequestering.
