ASSISTANT COMMISSIONER'S REPORT:

General

- Urban Forest Master Plan Review
 - Update Commission Approved Draft available at <u>Trees in the City Right Tree</u>, <u>Right Place | City of Worcester</u>, <u>MA (worcesterma.gov)</u>
 - Assistant Commissioner Antonelli gave an update on the Urban Forest Master Plan, he informed that the Master Plan is now posted online, it went to City Council, and it was referred to a City Council Sub-Committee. He added that there were some excellent responses at City Council. He also said that a discussion needs to be had about tree planting. He said the Master Plan and the policy for tree planting would be separate entities, and that he anticipates the Master Plan be approved quicker than the tree planting policy.
 - Commissioner Karoway-Waterhouse asked if there was any data on how many trees didn't get planted because of homeowners not wanting them.
 - o Mr. Breveleri didn't want to give a wrong number, he estimated 50 or more, because they had to find different places to plant them at.
 - Assistant Commissioner explained that the trees were planted they just had to find new locations when they were rejected by the homeowners.
 - Mr. Breveleri said that after the issue with ALB (Asian Longhorned Beatle) they were planting from 600 to 900 trees per year, per planting season, but there was a lot of resistance in some of the neighborhoods.
 - Commissioner Karoway-Waterhouse asked if there was any way to collect the data of the neighborhoods that are resisting to the planting.
 - Mr. Breveleri said it could be done but it would take time to enter it into the software they use for tree tracking.
 - Commissioner Elton said that assuming that some of the refusals are in concentrated areas, they
 can strategize to go to neighborhood groups, church groups, rec centers and talk to people,
 including leaders in these neighborhoods, to explain the importance of trees and to try to get
 them on board with the city.
 - Commissioner Winbourne asked how the trees being tracked.
 - Mr. Breveleri explained that they enter it into the Davey Software, the type of tree and the location.
 - Commissioner Winbourne suggested the report of the trees to have 3 categories "Got planted",
 "Someone didn't want it" or "There's some physical reason it could be planted"
 - Commissioner Karoway-Waterhouse said she wouldn't need to know the reason why a person didn't want a tree, she just wanted to look at the data of areas where the more refusals.
 - Assistant Commissioner said they are currently going out to bid for Tree Planting with a new contract specifically for ARPA. He said there was some funding coming in from the department of Sustainability and Resiliency and they need to have the right language to meet the ARPA requirements.
