The Worcester Regional Transit Authority (WRTA), the Federal Transit Administration (FTA) Section 5307 (c) grant applicant, a member of the CMMPO, states that the public involvement process adopted for the development of the TIP satisfies the public hearing requirements that pertain to the development of the Program of Projects for regular Section 5307, Urbanized Area Formula Program, grant applications including the provision for public notice and the time established for public review and comment.

The **LRTP** “Mobility2040” includes policies, initiatives and multi-modal infrastructure improvement projects anticipated for implementation over the next 25-year period. The **TIP** is the listing of all transportation projects-highway, transit, intermodal-in the planning region programmed to receive federal-aid funding. Proposed Amendment #4 to the 2016-2019 TIP calls for changes to FY 2016 of the highway & transit project listings. Further, the **UPWP** details the transportation planning work to be completed in the region over the next program year, associated funding and anticipated work products.
