Approval of the Minutes – October 16, 2014 – Upon a motion the Commission voted 2-0 to approve the minutes of October 16, 2014.

**One Day Liquor & Entertainment Requests:**

1. Petition: Request for one day liquor license
  - November 1, 2014 – 3:00 p.m. – 7:00 p.m.

Petitioner: Worcester Historical Museum

A representative from the Worcester Historical Museum appeared on behalf of the item and stated that this will be for an event at the museum.
