1. Sampson Tona, dba Ash Liquors, 1067 Main Street

• Request for package store malt & wine license

Attorney David Officer and Sampson Tona called in for the application.

Chairman Shea stated that the Commission had received the Law Department memo that stated that the Commission could not limit the type of beer sold in the establishment and he stated that he visited other stores in the area and they sell Ghanaian beers.

Mr. Officer stated that the products that Mr. Tona plans to sell would increase number of people coming to the area and this area has become business area for Ghana community and will serve an underserve community.

Commissioner Haller stated that she cannot support the application as because once the license is issued the Commission can't restrict type of beers and the area is adequately served and the license is not needed and cannot support it.

Mr. Officer stated that Mr. Tona is only looking for package store license to meet the demand of the Ghana community in that area.

Commissioner Salvidio stated that he believes there is a uniqueness on the product and the community that it will serve so he would support the application.

Chairman Shea reiterated that that he had visited the area and there are 3 package stores right in the area and believes the area is well served
