- 4. Parking Plan Approval 492 Park Avenue (Wendy's): Upon a motion by Joseph Sova and seconded by Perry Hanson, the Board voted unanimously to approve the parking plan with the following conditions:
  - \* Left turns prohibited onto Park Avenue from parking lot.
  - \* Eight (8) foot stockade fence be installed all along the back of the property and around dumpster. Six (6) foot arbor vitae between Levesque property and fence and around dumpster site be installed and shown on revised plan.


