The School Committee held a meeting on December 7, 2023 in the Esther Howland Chamber in City Hall. The meeting was called to order at 5:00 p.m. by Mayor Petty. There were present: Member Kamara, Member Mailman, Member McCullough, Mayor Petty and Member O'Connell Novick. Member Clancey joined Executive Session virtually.

The Mayor made a motion at 5:07 p.m. to recess and move into Executive Session.

On a roll call of 5-0, the motion was approved at 5:08 p.m.

At 6:52 p.m. the roll call to convene in open session was approved.

There were present: Member Kamara, Member Mailman, Member McCullough, Member O'Connell Novick and Mayor Petty.

The School Committee began by recognizing Coach Meg Brunelle on her 200th career WPS Field Hockey win and Doherty Memorial High field hockey senior Hannah Murray concerning her 175+ scoring point record during her highschool career. Member McCullough thanked Coach Brunelle for her hard work and dedication to Worcester Public School students and athletes. Coach Brunelle highlighted Hannah Murray's accomplishments which include 100 points during her junior year and 100 goals during her senior year which is something she hasn't seen in her 15 years as a coach.

To recognize former Worcester School Committee member Jack Foley as the recipient of a Life Membership Award from the Massachusetts Association of School Committees.

Member O'Connell Novick read a statement from MASC giving the reasoning for awarding Mr. Foley with this Life Membership Award. Mr. Foley thanked the MASC President and Executive Director for the honor of receiving the lifetime membership. He thanked Member O'Connell Novick, the entire School Committee and the Mayor for their hard work over the last few years in creating necessary support and opportunities for Worcester Public School Students.

THE STRATEGIC PLAN PROCESS



For nearly two years, the School Committee and Superintendent engaged the community regarding the future of the Worcester Public Schools. The Superintendent search process included surveys and focus groups. The community-led search process led to the selection of the new Superintendent. The Superintendent conducted a Listening and Learning tour throughout the community that created themes as priorities for the district. The strategic plan process created a community task force that also included frequent updates to the School Committee.



The data collected from the Listening and Learning tour suggested that the district focus on equitable educational opportunities for all students (Pre-K- 12), expand family and community engagement opportunities, strengthen inclusive learning environments, invest in our employees and our facilities, and focus on the mental and physical health of students, staff, and caregivers. Priorities were shared with the Governance and Employee Issues subcommittee and the full School Committee in an iterative process.



The Standing Committee on Governance and Employee Issues held a meeting on November 21, 2023 in Room 410, Durkin Administration Building, 20 Irving Street.

Chairperson Clancey called the meeting to order at 4:32 p.m.

Present were Member Johnson and Member McCullough.

Also present were non-standing committee Members Mailman and O'Connell Novick, Deputy Superintendent Allen and Interim Clerk Rushford.

Approval of Donations:

To accept a donation in the amount of \$350,000 from the Gene Haas Foundation to Worcester Technical High School and the Skyline Technical Fund, Inc for facility improvements and equipment purchases for the Advanced Manufacturing Program in exchange for signage and fifteen year naming rights of the space within the school as the Gene Haas Center for Advanced Manufacturing.

Chairperson Clancey made a motion to Hold the item. On a roll call vote of 3-0, the item was held.

General Business:

The following items were taken together:

qb-3-234.1 Mayor Petty

(October 6, 2023)

Request the rules of the school committee be amended to allow an item to be placed on the agenda of a school committee meeting after the Wednesday deadline and before the 48 hour open meeting law posting time with the consent of the mayor.

gb-3-236.1 Johnson

(October 11, 2023)

To look at the current rules of the Worcester School Committee and update in preparation for the new School Committee starting in January 2024.

The Members received a document from Deputy Superintendent Allen with recommended additions, deletions and updates.

The committee members reviewed Mr. Allen's proposed changes one by one. Member McCullough suggested eleven changes to the rules also. Chairperson Clancey suggested two changes.

Member Johnson asked for clarification of a number of the proposed changes including the elimination of many of the rules pertaining to the Student Advisory Committee. Mr. Allen responded that those points referenced in the rules and being eliminated will be recommended at the December 7, 2023 School Committee meeting to be added as part of the student handbook.

Chairperson Clancey made a motion to approve the changes as the new Rules of the School Committee effective January 2, 2024 as follows:

Moering

Rules of the School Committee Approved on 2-17-22 amended on 5-5-22

Proposed: November 21. 2023 for the 2024-2025 School Committee Term

1. The School Committee shall consist of the Mayor and six (6) members eight (8) members. All members are, by municipal charter, elected during odd year November municipal elections for a two-year term beginning each even-numbered January.

- 2. At all meetings of the Worcester School Committee, four (4) five (5) members shall constitute a quorum for the transaction of business.
- 3. The Mayor shall, by municipal charter, serve as the Chair of the School Committee. The Mayor shall have no power to veto, but shall serve as a full voting member of the Committee.
- 4. The Chair shall call the School Committee to order at the time appointed for the meeting and shall preside and cause the records of the last regular meeting and subsequent special meetings to be presented or read, and if they are found correct, the School Committee shall declare them approved. The Chair shall have the power to open the session at the time the School Committee is to meet, by taking the Chair, and calling the members to order; to announce the business in the order in which it is to be acted upon; to recognize members entitled to the floor; to state and to put to vote all questions which are regularly moved and to announce the result of the vote; to enforce on all occasions the observance of order and decorum among the members; to decide all questions of order (subject to an appeal to the committee by any member who submits the question to the entire School Committee). The Chair cannot close debate unless by two-thirds (2/3) vote of the members of the School Committee present.
- 5. The Chair shall sign all diplomas awarded in all schools.
- 6. A Vice-Chair shall be chosen by Committee vote at the first meeting of the term for the full term. Each member shall name their selection for Vice-Chair.
- 7. The Vice-Chair shall, in the absence of the Chair, call to order and chair any meeting of the full committee, shall take the chair should the Mayor wish to address business before the Committee, and shall have further duties as delineated below.
- 8. No member of the School Committee, including the Chair, shall exercise authority outside of Committee meetings nor exercise any administrative responsibility with respect to the schools unless such authority has been specifically delegated to him/her by statute, by Committee rule, or is consistent with state statutes. No member of the Worcester School Committee may direct any Worcester Public Schools employee.

- 9. The School Committee by its vote or as individual members of the School Committee shall deal with any School Department employee through the Superintendent, its executive officer, who under the general direction of the Committee, is charged with the care and supervision of the public schools. Individual School Committee members may deal with any School Department Cabinet-level employees, without notice to the Superintendent, concerning day-to-day matters of a routine nature regarding the administration of the school system, as long as such dealings would not cause any disruption in the course of the performance of that employee's duties or direct their work. In those situations where the definition of "routine" is in question, that issue may be resolved by the Superintendent. School Committee members should only attend school events when invited by the school-based leadership and should notify the Superintendent or Executive Directors of visits to individual schools.
- 10. No member of the School Committee shall vote on any question or serve on any committee where his/her private interest is immediately concerned or where a conflict of interest exists as defined by state statutes and/or judicial interpretation.
- 11. A meeting of the Committee may be called by the Chair, by the Vice Chair, or by any other three four members of the Committee.
- 12. All meetings must be posted in accordance with the Open Meeting Law at least 48 business hours in advance of the meeting. Worcester School Committee meetings are posted by the City Clerk.
- 13. Regular meetings of the Worcester School Committee will take place on the first and third Thursday of each month at 6 p.m. The Vice-Chair can set the meeting to start earlier than this time but no sooner than 5 p.m. based on the expected length of any scheduled executive session. In July and August, the Committee will meet solely on the third Thursday. In June, both meetings will begin at 4 pm for budget deliberation. The School Committee will approve a meeting calendar for the upcoming calendar year.
- 14. The seats of the members, with the exception of the Chair, should be numbered and determined by lottery and may not be changed unless by permission of the Chair. As a matter of protocol, the Chair while presiding at regular School Committee meetings shall be seated between and flanked by the Superintendent and the Clerk of the School Committee.
- 15. The Chair shall observe the following procedures in conducting the meetings:
 - a. recognizing members in order of request to be heard
 - b. acting upon the motion on the floor before other motions are entertained
 - c. discouraging argumentative and repetitive discussion
 - d. relinquishing the Chair when desiring to engage in discussion or debate of the agenda item

When a question is under debate the Chair shall receive no motion but:

- e. to refer
- f. to hold to a certain day/indefinitely
- g. to allow debate to continue on a motion

The Standing Committee on Finance and Operations-Finance, Operations, and Governance provides the full year oversight of the budget of the Worcester Public Schools as required by Massachusetts General Laws Ch. 71, sec. 37 through the review of quarterly budget reports, the reception of reports of the auditors, and issues of payroll, procurement, and financial management and planning that may fall under the purview of the Committee. The Standing Committee provides for facilities management, repair, and capital planning so far as it is under district purview. The Standing Committee also oversees the operational aspects of the district under the departments of School Nutrition, Student Transportation, Information Technology, and School Safety. The Committee will also this committee review, update and/or

institute all policies governing the Worcester Public Schools. The Deputy Superintendent will be the Administrator in Charge of this Committee.

Governance and Employee Issues

The purpose of this committee is to review, update and/or institute all policies governing the Worcester Public Schools. This committee is also responsible for issues related to employees/staff including human resource recruitment, hiring, retention, and evaluations, so far as it is under Committee purview.

School and Student Performance

The purpose of the School and Student Performance Standing Committee is to inquire into and report on matters pertaining to:

- measures of district and school level performance and improvement
- research and program evaluation
- student assessment
- accountability planning

Teaching, Learning and Student Supports Success

The Standing Committee on Teaching, Learning and Student Supports Success addresses topics, policies and practices related to curriculum, instruction, assessment, district and school-level performance and improvement, research and program evaluation, accountability planning, professional development, instructional materials, and student support services. In doing so, the Committee monitors and reviews the structures and processes integral to the delivery of the core curriculum. It focuses as well on supplemental and intervention instruction, designed to meet the academic and social-emotional needs of students as each school strives to reach the intended outcomes of college and career readiness for every student. The content and annual edits to the Student Handbook and the Policies Handbook will be referred to the Standing Committee on Governance and Employee Issues prior to approval by the Full School Committee. The Assistant Superintendent will be the Administrator in charge of this Committee.

 41. Each Committee shall consist of no less than three (3) four (4) School Committee Members.
 - 42. Meetings of the Standing Committee may be called by the chair of the Standing Committee or by the two three other members of the Standing Committee.

The minutes of any executive session, the notes, recordings or other materials used in the preparation of such minutes and all documents and exhibits used at the session, shall be withheld from public disclosure to the extent provided by subsection 22(f) of the Open Meeting Law, G.L. c. 30A §§ 18-25. The Mayor shall, at reasonable intervals or as otherwise required by subsection 22(g)(2) of the Open Meeting Law, G.L. c. 30A §§ 18-25, review any previously unreleased minutes of all executive sessions and determine whether continued non-disclosure under the Open Meeting Law is warranted. In conducting this review, the Mayor may seek the advice and assistance of the Superintendent, Clerk of the School Committee, the City Manager or City Solicitor. The Mayor shall file a report containing such determinations at the next regular meeting of the School Committee.

Members shall be elected each spring by their peers at each city secondary school, including the alternative programs for a term the succeeding year. Purpose:

To inform the student body of the functions and workings of the School

Committee. To represent to the School Committee a cross-section of the entire

student body.

Regular Responsibilities:

- Be accessible to, and representative of, the entire student body.
- Gather collective sentiment that is representative of the entire student body and present those views to the full Committee.
- Share information among the Committee, staff, and students.
- Contribute to Committee deliberations.
- Communicate with staff and students about student concerns and help develop solutions.
- Collaborate with other student representatives and members of the School Committee.

Ex-Officio Member Responsibilities:

- Attend every Regular Session meeting during their term
- Prepare and present a "Student Report" at every Regular Session that includes, but is not limited to: student events, concerns, recommendations, projects, etc
- Attend Standing Committee and Special/Ad Hoc Committee meetings to share sentiment of the student body
- Contribute to Committee deliberations where appropriate

Student Advisory Committee Representative Responsibilities:

- Attend Regular Sessions during their term when scheduled, if possible
- Help prepare and present a "Student Report" at every Regular Session that includes,
 - but is not limited to: student events, concerns, recommendations, projects, etc.
- Encouraged to attend Standing Committee and Special/Ad Hoc Committee meetings to share sentiment of their respective student body

Rules of the School Committee Approved on 2-17-22 amended on 5-5-22

Proposed: November 21. 2023 for the 2024-2025 School Committee Term Beginning January 2, 2024

- 1. The School Committee shall consist of the Mayor and six (6)-members eight (8) members. All members are, by municipal charter, elected during odd year November municipal elections for a two-year term beginning each even-numbered January. Two members shall be elected at-large citywide; six shall be elected from geographic districts as designated by the municipal chart.
- 2. At all meetings of the Worcester School Committee, four (4) five (5) members shall constitute a quorum for the transaction of business.
- 3. The Mayor shall, by municipal charter, serve as the Chair of the School Committee. The Mayor shall have no power to veto, but shall serve as a full voting member of the Committee.
- 4. The Chair shall call the School Committee to order at the time appointed for the meeting and shall preside and cause the records of the last regular meeting and subsequent special meetings to be presented or read, and if they are found correct, the School Committee shall declare them approved. Items that are recognitions will be placed on the consent agenda; items that note upcoming events will be placed under announcements.
- 27. On the Friday Thursday preceding a regular meeting, the agenda of the Committee will be assembled by the Clerk, in consultation with the Superintendent and the Vice Chair. The agenda will then be posted by the Clerk of the Worcester School Committee and will be officially posted by the City Clerk
- 28. The assembly of the agenda should be done with respect to the calendar of the Worcester Public Schools as well as the calendar of the Committee.
- 28: The agenda of the Committee will be as follows:
 - a. General Business items taken in Executive Session.

- b. Call to order
- c. Pledge of Allegiance
- d. Roll call
- e. Consent agenda
 - i. Approval of minutes
 - ii. Approval of donations
 - iii. Notification of personnel records
 - iv. initial filing of recognitions
 - v. notices of interest to the district or to the public
- f. Items for reconsideration
- g. Held Items
- h. Recognitions
- i. Public comment
- j. Public petitions
- k. Report of the Superintendent
- I. Report of the Standing Committee/s
- Report of the Student Representatives/Student Advisory Committee
- n. Approval of grants and other finance items
- o. General business
- p. Announcements
 - During the bi-monthly Student Advisory meeting, item L will be taken up directly following the roll call.
- 29. Any item may be removed from the consent agenda to the general business agenda by majority vote of the Committee.
- 30. Any member of the public may address the Committee regarding any item before them for two (2) minutes. Those speaking will state their name, their residence, and the item on which they wish to speak for the record. Those speaking may do so in person or via remote participation. Those wishing to address the Committee in a language other than English are asked to notify the Clerk of the Committee in advance, so the Committee may be provided with an interpreter. Members of the Committee may not respond to the comments of the public at the meeting.
- 31. Any member of the public may file a petition to the Committee on any matter under the Committee's purview by submitting such a petition in writing (on paper or electronically) by the Wednesday of the week prior to a regular meeting of the Committee. Anyone so filing will be invited to address the Committee on their petition at the meeting of the Committee on which such item appears. Any Standing Committee receiving such a referral will endeavor to take up any such petition within 60 days. When such an item appears on Standing Committee agenda, the petitioner will be invited to the meeting.
- 32. There will be a report of the Superintendent at every regular meeting of the Committee. Said reports will specifically be in reference to the goals of the district and/or of the superintendent.
- 33. There will be a calendar of regular reports of the Superintendent, as follows:

First February meeting Following the filing of the Governor's budget: Report on

the Governor's budget

July meeting: Evaluation of the superintendent

August meeting: Back to school report Second October meeting: MCAS report

First December meeting: Superintendent's midcycle review

- 34. All petitions, communications, items or any matter before the School Committee may be referred as follows:
 - a. to a Standing Committee of the School Committee
 - b. to a Special Committee of the School Committee
 - c. to the Superintendent/Administration
- 35. All items referred to Administration for study and recommendation shall include in the item a suggested date for a report back to the full Committee. The length of time allowed for the study shall be determined by its complexity. The Committee shall be aware of the limited time available for study items during budget preparation and hearing months. The direction, scope and intent to the study shall be specific.
- 36. A petition, resolution, order, communication or other matter acted upon unfavorably by the School Committee including placing on file such petition, order, or other matter or the substance thereof, shall not again be docketed on the School Committee agenda for consideration by the School Committee within a period of three (3) months of such unfavorable action unless previously authorized by two-thirds (2/3) vote of the School Committee Members present.
- 37. The conduct of meetings of the business of the School Committee shall be in accordance with the laws of the State, and except as otherwise provided, in accordance with the rules of parliamentary procedure laid down in Robert's Rules of Order, 12th edition.
- 38. All meetings of the School Committee shall be open to the public except for executive sessions as described below:
 - No executive session shall be held until the School Committee has first convened in open session for which notice has been duly given, a majority of the members have voted to go into executive session, and the vote of each member is recorded on a roll call vote and entered into the minutes, the Chair has cited the purpose for an executive session, and the Chair has stated before the executive session if the School Committee will reconvene after the executive session.
- 39. All Committees shall be appointed by the Chair unless otherwise ordered by the School Committee. All Chairs and Vice-Chairs must have attended the Massachusetts School Committees Charting the Course training prior to their assignment. Each School Committee member shall serve on no less than one standing committee. Each School Committee member shall serve on no less than two one standing committees. A majority of each Committee shall constitute a quorum. All reports made by Committees to the School Committee

shall be presented by the Standing Committee Chair. Minority reports may be given by members of the Standing Committee as long as the issues raised were discussed in the Standing Committee.

- 40. There shall be appointed Standing Committees of the School Committee as follows:
 - a. Finance and Operations Finance, Operations, and Governance
 - b. Governance and Employee Issues
 - c. School and Student Performance
 - d. Teaching, Learning, and Student Supports Success

Finance and Operations Finance, Operations, and Governance

The Standing Committee on Finance and Operations Finance, Operations, and Governance provides the full year oversight of the budget of the Worcester Public Schools as required by Massachusetts General Laws Ch. 71, sec. 37 through the review of quarterly budget reports, the reception of reports of the auditors, and issues of payroll, procurement, and financial management and planning that may fall under the purview of the Committee. The Standing Committee provides for facilities management, repair, and capital planning so far as it is under district purview. The Standing Committee also oversees the operational aspects of the district under the departments of School Nutrition, Student Transportation, Information Technology, and School Safety. The Committee will also this committee review, update and/or institute all policies governing the Worcester Public Schools. This committee is also responsible for issues related to employees/staff including human resource recruitment, hiring, retention, and evaluations, so far as it is under Committee purview. The Deputy Superintendent will be the Administrator in Charge of this Committee. The content and annual edits to the Student Handbook and the Policies Handbook will be referred to the Standing Committee on Governance and Employee Issues prior to approval by the Full School Committee.

Governance and Employee Issues

The purpose of this committee is to review, update and/or institute all policies governing the Worcester Public Schools. This committee is also responsible for issues related to employees/staff including human resource recruitment, hiring, retention, and evaluations, so far as it is under Committee purview.

School and Student Performance

The purpose of the School and Student Performance Standing Committee is to inquire into and report on matters pertaining to:

- measures of district and school-level performance and improvement
- research and program evaluation
- student assessment
- accountability planning

Teaching, Learning and Student Supports Success

The Standing Committee on Teaching, Learning and Student Supports Success addresses topics, policies and practices related to curriculum, instruction, assessment, district and school-level performance and improvement, research and program evaluation, accountability planning, professional development, instructional materials, and student support services. In doing so, the Committee monitors and reviews the structures and processes integral to the delivery of the core curriculum. It focuses as well on supplemental and intervention instruction, designed to meet the academic and social-emotional needs of students as each school strives to reach the intended outcomes of college and career readiness for every student. The content and annual edits to the Student Handbook and the Policies Handbook will be referred to the Standing Committee on Governance and Employee Issues prior to approval by the Full School Committee. The Assistant Superintendent will be the Administrator in charge of this Committee.

- 41. Each Committee shall consist of no less than three (3) four (4) School Committee Members.
- 42. Meetings of the Standing Committee may be called by the chair of the Standing Committee or by the two three other members of the Standing Committee.
- 43. If an item is referred to a Standing Committee and has no action for two consecutive meetings, the maker of the original item may request the item be returned to the full committee.
- 44. The principal petitioner of any petition to be heard by a Standing Committee of the School Committee must be notified of the date, time and place at which their petition is to be heard by the Clerk of the School Committee. No petition may be voted by a Standing Committee of the School Committee unless the principal petitioner has been notified as specified above.
- 45. The Chair of any Standing Committee who does not call a meeting of the committee for six months shall be removed as chair, and the Mayor shall appoint another member in that member's stead.
- 46. Whenever a vacancy occurs among School Committee Officers, or in any Committee, the same shall be filled by election or appointment in the same manner and by the authority which first elected the officer or appointed the Committee.
- 47. The Clerk of the School Committee shall create and maintain an accurate record of all meetings of the School Committee and all of its committees, including executive sessions, setting forth the date, time and place, the members present or absent, and a summary of the discussions on each subject. The record shall include all documents and other exhibits, such as photographs, recordings or maps, used by the School Committee or any committee thereof at any open session or executive session.

- 48. The minutes of any open session, whether approved or in draft form, shall be made available upon request by any person within ten (10) days of the request to the extent required by subsection 22(e) of the Open Meeting Law, G.L. c. 30A §§ 18-25.
- 49. The minutes of any executive session, the notes, recordings or other materials used in the preparation of such minutes and all documents and exhibits used at the session, shall be withheld from public disclosure to the extent provided by subsection 22(f) of the Open Meeting Law, G.L. c. 30A §§ 18-25. The Mayor shall, at reasonable intervals or as otherwise required by subsection 22(g)(2) of the Open Meeting Law, G.L. c. 30A §§ 18-25, review any previously unreleased minutes of all executive sessions and determine whether continued non-disclosure under the Open Meeting Law is warranted. In conducting this review, the Mayor may seek the advice and assistance of the Superintendent, Clerk of the School Committee, the City Manager or City Solicitor. The Mayor shall file a report containing such determinations at the next regular meeting of the School Committee.
- 50. The Chair/Vice Chair and/or the Administration shall be the ones to seek legal opinions on any item. These requests can come on behalf of School Committee members through the Chair/Vice-Chair and/or the Administration.
- 51. There will be a School Committee Student Advisory Committee, as created by G.L. c. 71§§ 38M. Members shall be elected each spring by their peers at each city secondary school, including the alternative programs for a term the succeeding year. The results of such election will be forwarded to the Clerk of the School Committee by the first week of June.
- 52. The members of said Committee are recognized by the Worcester School Committee as the elected representatives of the students of the Worcester Public Schools. The members of the Student Advisory Committee thus are not to be subjected to district pressure regarding their opinions. The contact information of the members of the Student Advisory Committee will be shared with all K-12 Worcester Public School Students.
- 53. It will be the responsibility of the Clerk and the Vice Chair to ensure that the Student Advisory Committee meets once a month on its own and once every other month, as required by G.L. c. 71§§ 38M with the entire Worcester School Committee.
 - (MGL 71 Section 38M. School committees of cities, towns and regional school districts shall meet at least once every other month, during the months school is in session, with a student advisory committee to consist of five members to be composed of students elected by the student body of the high school or high schools in each city, town or regional school district.)
- 54. Members of the Student Advisory Committee will decide, when meeting among themselves, what items will be brought forward to the Worcester School Committee on its next agenda and shall prepare those items for submission to the Clerk and the Vice-Chair with the same deadlines as items submitted by

other members.

55. The chair of the Student Advisory Committee, as elected by its members, shall serve as a non-voting member of the Worcester School Committee. This member will have dedicated time on each agenda to bring forward the business of the Student Advisory Committee. This, and any, member of the Student Advisory Committee has the same right to be recognized by the Chair and to speak on any business before the Committee as any other Worcester School Committee member in public session.

Basic Description:

The Student Advisory Committee, composed of eight Student Representatives to the Worcester School Committee, shall include students enrolled in a public or alternative school within the Worcester Public School district, elected by the students of each high school. The Student Advisory Committee shall, in accordance with Chapter 71 Section 38M of Massachusetts General Law, elect from their number a chair person who shall serve a term of one year as an ex officio member of the School Committee. They are subject to the same privileges as other School Committee members and are to be held subject to the same rules except with the ability to vote, and unless permitted to do so by the School Committee to attend Executive Session.

Purpose:

To provide for a meaningful link and to promote a mutual sense of respect and understanding between the student body and the School Committee.

To represent before the School Committee, the attitudes, interests and concerns, both positive and negative, of the student body.

To advise the School Committee and add insight to their deliberations.

To carry to the School Committee and to support proposals and items of concern to the student body, and to initiate, on behalf of the student body and in conjunction with the student government, projects and proposals for presentation to the School Committee.

To inform the student body of the functions and workings of the School

Committee. To represent to the School Committee a cross-section of the entire

student body.

Regular Responsibilities:

- Be accessible to, and representative of, the entire student body.
- Gather collective sentiment that is representative of the entire student body and present those views to the full Committee.
- Share information among the Committee, staff, and students.
- Contribute to Committee deliberations.
- Communicate with staff and students about student concerns and help develop solutions.
- Collaborate with other student representatives and members of the School Committee.

Ex-Officio Member Responsibilities:

- Attend every Regular Session meeting during their term
- Prepare and present a "Student Report" at every Regular Session that includes, but is not limited to: student events, concerns, recommendations, projects, etc
- Attend Standing Committee and Special/Ad-Hoc Committee meetings to share sentiment of the student body
- Contribute to Committee deliberations where appropriate

Student Advisory Committee Representative Responsibilities:

- Attend Regular Sessions during their term when scheduled, if possible
- Help prepare and present a "Student Report" at every Regular Session that includes,
 - but is not limited to: student events, concerns, recommendations, projects, etc.
- Encouraged to attend Standing Committee and Special/Ad-Hoc Committee meetings to share sentiment of their respective student body

She also noted that all health education positions are staffed at this time, although a few teachers are out on leave, there are long-term substitutes covering them.

Dr. Gania noted that there is an approved K-12 health curriculum, of which sex education is a piece of and she clarified that there is an opt-out option on the sex education piece of the health curriculum only.

I. The meeting was called to order at 4:00 p.m. by Chairperson O'Connell Novick.

II. Public Comments:

- 1. Aislinn Doyle, Worcester, MA spoke to a request to limit the maximum number of students allowed on a school bus.
- 2. Emily Konstan, of Worcester, spoke on reducing the bus privilege eligibility from 2 miles to 1 mile.
- 3. LaShawna Fulton of Worcester spoke to the Committee in support of increasing the number of bus monitors in response to overcrowding and bullying on school buses.
- 4. Mia Desilatt of Worcester spoke regarding offering cultural lunch options, the use of nearly \$500,000 that the district received in April or May for the support of Afghan refugees, and funding for safe spaces for English Language Learners (ELL).

III. Business Items

c&p 3-14.1 Doyle

(November 28, 2023)

Request that the school committee consider adopting a policy that addresses: the maximum number of children allowed to ride on an elementary school bus, the maximum number of children allowed to ride on a secondary school bus, the maximum number of students that can be assigned to a school bus route, and the number of elementary riders there might need to be reached to require a bus monitor be assigned to a bus to assist the driver in keeping children safe.

Mr. Allen noted, while the Administration agrees with the sentiment of additional buses, we are unable, at this time, to add routes due to a lack of drivers. While buses are available, we are short staffed on bus drivers at this time. He noted that if this changes in the future, we may be able to reconsider adding buses or bus monitors.

Mr. Hennessy explained that a new charter school, which WPS is legally obligated to provide transportation for, is using some capacity; however, rebalancing bus routes does routinely happen throughout the school year.

After discussion, Chairperson O'Connell Novick made a motion to file the report. Roll Call Vote: Vice Chair Kamara, No. Member Mailman, yes. Chairperson O'Connell Novick, yes. Motion passes, 2-1.

gb 3-206.1 McCullough

(August 26, 2023)

To review the district transportation policy regarding transportation only provided two or more miles from the assigned school. With n-house transportation, explore the ability to reduce that to less than 2 miles.

Mr. Hennessy and Dr. Andrew Lampier explained a recent analysis of correlation between attendance rates and distance lived from the school building, as well as data involving a number of other factors.

Their findings included student race, ethnicity, and ELL status were all contributing factors affecting attendance rates (high school only). The data also showed that the further away from school that a student lived the less they attended school. For every ¼ mile away from school, students missed 1.25 days of school on average.

Mr. Allen noted that changing bus eligibility by ¼ mile would require 9 additional buses. The barrier for making this change is the number of school bus drivers at this time.

Committee members discussed the possibility of a partnership between Worcester Public Schools and the Worcester Regional Transit Authority (WRTA). While some students already utilize the fare-free bus system, bus capacity, strict published bus routes, and lack of safety mechanisms (i.e. stop signs and flashing lights) contribute to the lack of feasibility.

Chairperson O'Connell Novick made a motion to file the report. On a voice vote, the motion passes, 3-0.

<u>GENERAL BUSINESSgb 2-23.4 Johnson/Kamara/Clancey/Mailman/O'Connell Novick</u>

(January 12, 2022)

To consider a pilot of provision of menstrual supplies at all secondary schools.

Mr. Ikonen noted that 94 dispensers will be installed next week to provide menstrual supplies to students free of charge.

Machines will be installed outside of bathrooms and will be maintained and refilled by the custodial staff.

Mr. Allen replied to a question from Chairperson O'Connell Novick, that this is phase I of this program and will be completed at high school locations. Phase II of this program will begin upon Phase I completion and will include middle and elementary schools.

Chairperson O'Connell Novick made a motion to file the report. On a voice vote, the motion passes, 3-0.

<u>gb 3-241.1 McCullough</u> (October 23, 2023)

To ensure all flag poles at WPS buildings are in working order and ensure that proper protocol is being followed. Additionally, consider solar pole lighting as applicable/necessary.

Mr. Ikonen noted he has established a protocol to view flagpoles and ensure they are operational.

Mr. Ikonen and his team will do routine maintenance annually, and may require an outside vendor if specialized lifts are needed. He will first investigate if borrowing equipment from the City of Worcester DPW will be feasible before using WPS funds to rent or outsource.

Chairperson O'Connell Novick made a motion to file the report. On a voice vote, the motion passes, 3-0.

gb 2-92.14 Clancy

(March 8, 2022)

Request that the Administration provide quarterly reports regarding building maintenance to include timeframes on when work will begin and be concluded.

Chairperson O'Connell Novick made a motion to hold the report. On a voice vote, the motion passes, 3-0.

gb 3-94.1 Johnson

(March 21, 2023)

Request administration look into options available regarding vaping detectors being purchased and placed in all secondary schools.

Dr. Morse presented the Committee data from a pilot program called Halo vape detection system, which is able to integrate with our current technology.

The cost of the total program for 103 restrooms would be between \$216,000 and \$370,000. Because of this investment, Dr. Morse recommended a pilot program of four (4) systems. This would cost between \$8400-\$14,000.

After discussion amongst the Committee regarding the usefulness of this program, the Committee made a motion to decline the pilot program "Halo" and made an additional motion to recommend public health and personnel solutions towards vaping. On a voice vote, both motions pass, 3-0.

gb 3-218.1 McCullough

(September 5, 2023)

To enhance nutrition/lunch options as possible to line up with dietary and cultural needs.

Ms. Donna Lombardi addressed this issue with the Committee. She noted several barriers facing the food services department that include being short 100 or more workers and procurement challenges. Ms. Lombardi noted that she is seeking new sources for meat, yogurt and cheeses and she hopes to provide a survey to students along with food samples.

After being asked where the bottlenecks were occurring she noted that WPS has been unable to restore labor levels and some smaller schools with off site kitchens were presenting a challenge. However, Ms. Lombardi informed the Committee that the City of Worcester and the WPS are working together to streamline the application and hiring process.

Chairperson O'Connell Novick made a motion to file. On a voice vote, the motion was approved 3-0. Motion passes.

gb 3-223.1 O'Connell Novick

(September 13, 2023)

Request administration report on the Information Technology systems implementation and needs, including, as necessary, policy and budgetary implications.

Mr. Bob Walton, Director of IT spoke on behalf of the department. The WPS IT department manages over 20 different applications for students and staff and

consists of three main components: networking, IT support/device repair, and information systems database software. This department supports hardware and software for every department in the WPS.

Mr. Walton informed the Committee he currently employs 40. He recommended adding a Chief Security Officer in a future budget plan to handle risk management plans, security policy, and incident report oversight.

Mr. Walton also reviewed his current and future budget needs with the Committee, including the hardware replacement cycle needs of the districts.

Chairperson O'Connell Novick made a motion to file the report. On a voice vote, the motion passes, 3-0.

<u>gb 3-189.1 Mailman</u> (July 31, 2023)

To explore the feasibility and logic of hiring our own school attorney to assist in the execution of building repairs and maintenance, contractual obligations and whatever other items will assist in school operations. Submitted as an acknowledgment of the reality of the very overburdened city law department.

Mr. Allen addressed the Committee, noting that he did speak with City Solicitor Michale Traynor regarding this petition. It was Mr. Traynor's recommendation that the Committee not take any action on this item at this time.

Mr. Traynor, through Mr. Allen noted that he has hired a contract liaison and an additional attorney to assist with workflow and this has improved.

Chairperson O'Connell Novick made a motion to file the report. On a voice vote, the motion passes, 3-0.

gb 3-222.1 O'Connell Novick

(September 13, 2023)

Request administration report on the implementation of the Workday system, including, as necessary, policy and budgetary implications.

Sara Consalvo and Laura Cahill presented a Workday update to the Committee. Workday is an Enterprise Resource Planning (ERP) program that will be implemented across all City and WPS departments in the next 1-2 years.

It includes budgeting, accounting, banking, purchasing, time keeping, attendance, payroll and more.

Ms. Consalvo and Ms. Cahill described the various phases of implementation, which is ongoing and expected to be completed in 2025.

Mr. Allen noted there are no direct charges from the City to pay for Workday use at WPS, but payment will come via the net school spending assessment.

Ms. Consalvo requested support and patience as the implementation process proceeds.

Chairperson O'Connell Novick made a motion to file the report. On a voice vote, the motion passes, 3-0.

gb 2-319.1 O'Connell Novick

(December 8, 2022)

To consider the Budget Calendar.

Mr. Allen presented a budget timeline, similar to what has been previously presented. Chairperson O'Connell Novick requested this timeline be posted on the WPS website and Mr. Allen agreed. Vice Chair Kamara requested a video be produced to generate interest in the budget process and Mr. Allen agreed to discuss this with the Communications Department.

Corey Spaulding to request to know how the matter of Federal and State Grants are controlled, appropriated and accounted for as part of the fiduciary responsibility of the School Committee.

Mr. Allen included a grant spending overview and explained the process for applying for, receiving, and accepting grants. He noted all grants were included in the budget book, and appears on agendas when going before the School Committee for acceptance. Additionally, all grants are audited by the City of Worcester.

Chairperson O'Connell Novick made a motion to file the report. On a voice vote, the motion passes, 3-0.

Chairperson O'Connell Novick and Vice Chair Kamara both addressed the Committee with appreciation for being a part of the Finance and Operations Standing Committee during their tenure.

The Administration has been meeting with the community schools steering committee over the last few months. This committee is comprised of WPS employees, community organizations such as WEC, Health and Human Services, School-Based Health Centers, EAW, the United Way, Worcester Community Action Council, Greater Worcester Community Foundation, and many other community partners. The goal of this committee was to identify shared language around what is a community school, and one specific to the Worcester Public Schools. This committee also explored different community school models specific to urban school districts. This committee identified two final models (Equity-Focused Community School and the Full-Service Community School), at which time, both models were referred to the Superintendent's Cabinet to select one to propose to the School Committee.

The Superintendent's Cabinet chose to embed elements of the Equity-Focused Community School into the Full-Service Community School so that our focus would continue to be to close opportunity gaps of our historically underserved scholars.

At this time, we recommend referring this item to the Teaching, Learning, Student Support Standing Committee for further discussion.











WORCESTER PUBLIC COMMUNITY SCHOOL

Full-Service Community School: WPS aims to create an environment where all students can thrive academically, emotionally, and socially regardless of their background or circumstances by providing a wide range of services within the school building itself in order to address the comprehensive needs of WPS students and families. These services may include healthcare, mental health support, family counseling, after-school programs, adult education, and more. By offering these services on-site, the WPS full-service community school can create a convenient and accessible hub for WPS students and families to access resources and help to reduce barriers to learning while promoting the well-being of all community members.

Through its data-driven practices, the WPS Community School will identify disparities in achievement and discipline to inform strategies for improvement. This school will serve as the model for equity-focused work in an effort to actively dismantle barriers and systemic inequalities. WPS values community partnership as we engage with one another on a common purpose. As such, collaboration with community organizations, advocacy groups, and government agencies will be central to addressing systemic inequities.

In the spirit of continuous improvement, WPS will monitor and evaluate the services offered in our WPS Full-Service Community School through frequent qualitative and quantitative data collection to ensure the WPS full-service community school is making a positive impact on our school community.

Key features and components of the full-service Worcester Public Community School will include:

- Targeted Academic Supports: Provide targeted support and resources such as tutoring and homework assistance to students who may face educational or social disadvantages, such as students from low-income backgrounds, English language learners, students with disabilities, and students of color in order to close the opportunity gaps.
- Health Services: Provide an on-site health clinic or partnership with healthcare providers to
 offer services such as medical check-ups, dental care, mental health counseling, and nutrition
 education.
- Social and Emotional Learning (SEL) and Social and Emotional Support:
 - Embed social and emotional learning programs to help students develop skills like empathy, self-awareness, social awareness, and conflict resolution.
 - Provide counseling services, conflict resolution programs, and activities that promote social and emotional learning.
- Parent and Family Engagement: Offer resources and programs to help parents navigate the complexities of the school system empowering them to support their child's learning and development. A focus will be made on rising preschool and kindergarten students and all newly enrolled students.

- Programs Outside of School Hours: Offer programs, including sports, arts, youth empowerment opportunities, and extracurricular activities to include culturally focused activities, to keep students engaged in positive and productive activities outside of regular school hours, including during natural breaks throughout the school year and summer months.

Section 4-1 Composition. Term of Office and Powers.

- (a) Composition The School Committee shall consist of the Mayor, who shall chair the Committee and six eight members elected at-large. Two members shall be elected at-large citywide; six shall be elected from geographic districts as designated by the municipal chart.
- (b) Term of Office School Committee members shall be elected for terms of two years each, beginning on the first secular day of January in the year following their election and shall serve until their successors are qualified.
- (c) Eligibility Any voter shall be eligible to hold the office of School Committee member, provided, however, that he/she shall have resided within the City for one year immediately prior to the election.
- (d) Powers and Duties The School Committee shall have all the powers which are conferred on school committees by general law and such additional powers and duties as may be provided by the charter, by ordinance, or otherwise. Its powers and duties shall include, but shall not be limited to the following:
 - (1) To take general charge of all the public schools in the city, including the evening schools and evening high schools, and all special programs conducted by the school department.
 - (2) To appoint a Superintendent of the Schools who shall be charged with the day to day administration of the school system, subject to policy directives adopted by the school committee. The School Committee may award a contract to the Superintendent of Schools for a term not to exceed six years, in accordance with section 41 of Chapter 71 of the General Laws.

LEGAL REF.: Worcester City Charter, Article Four, Sec. 4-1d

File: BDE - STANDING COMMITTEES OF THE SCHOOL COMMITTEE

There shall be appointed Standing Committees of the School Committee, consisting of three members. The Chair of the School Committee appoints the chairs, vice chairs, and members of the following subcommittees for a period of two years:

Finance, Operations, and Governance

Teaching, Learning, and Student Success

Finance and Operations

Governance and Employee Issues

School and Student Performance

Teaching, Learning and Student Supports

These subcommittees are created for a specific purpose and to make recommendations for Committee action, as follows:

Finance and Operations: The Standing Committee on Finance and Operations provides the full year oversight of the budget of the Worcester Public Schools as required by Massachusetts General Laws Ch. 71, sec. 37 through the review of quarterly budget reports, the reception of reports of the auditors, and issues of payroll, procurement, and financial management and planning that may fall under the purview of the Committee. The Standing Committee provides for facilities management, repair, and capital planning so far as it is under district purview. The Standing Committee also oversees the operational aspects of the district under the departments of School Nutrition, Student Transportation, Information Technology, and School Safety. This committee is also responsible for issues related to employees/staff including human resource recruitment, hiring, retention, and evaluations, so far as it is under Committee purview.

Governance and Employee Issues: The purpose of this committee is to review, update and/or institute all policies governing the Worcester Public Schools. This committee is also responsible for issues related to employees/staff including human resource recruitment, hiring, retention, and evaluations, so far as it is under Committee purview.

School and Student Performance: The purpose of the School and Student Performance Standing Committee is to inquire into and report on matters pertaining to: - measures of district and school-level performance and improvement - research and program evaluation - student assessment - accountability planning

Teaching, Learning and Student Success Supports: The Standing Committee on Teaching, Learning and Student Supports addresses topics, policies and practices related to curriculum, instruction, assessment, professional development, instructional materials, and student support services. In doing so, the Committee monitors and reviews the structures and processes integral to the delivery of the core curriculum. It focuses as well on supplemental and intervention instruction, designed to meet the academic and social-emotional needs of students as each school strives to reach the intended outcomes of college and career readiness for every student. The Committee further reports on measures of district, school, and student performance and improvement.

The Standing Committee may make recommendations for Committee action, but it may not act for the School Committee.

All Standing Committees of the School Committee are subject to the provisions of the Open Meeting Law.

All reports made by Committees to the School Committee shall be presented by the Standing Committee Chair. Minority reports may be given by members of the Standing Committee as long as the issues raised were discussed in the Standing Committee.

If an item is referred to a Standing Committee and has no action for two consecutive meetings, the maker of the original item may request the item be returned to the full committee.

The principal petitioner of any petition to be heard by a Standing Committee of the School Committee must be notified of the date, time and place at which their petition is to be heard. No petition may be voted by a Standing Committee of the School Committee unless the principal petitioner has been notified as specified above.

File: JIB - STUDENT INVOLVEMENT IN DECISION-MAKING

As appropriate to the age of students, class or school organizations and school government organizations, such as student councils, may be formed to offer practice in self-government and to serve as channels for the expression of students' ideas and opinions.

The Committee will take into consideration student opinions in establishing policies that directly affect student programs, activities, privileges and other areas of student sensitivity.

Students will be welcomed at Committee meetings and granted privileges of speaking in line with the privileges extended to the general public.

Student Advisory Committee

As required by state law, the Superintendent will meet at least once every other month while school is in session with its student advisory committee, which is composed of at least five students elected by the high school student body.

The Student Advisory Committee, composed of eight Student Representatives to the Worcester School Committee, shall include students enrolled in a public or alternative school within the Worcester Public School district, elected by the students of each high school. The Student Advisory Committee shall, in accordance with Chapter 71 Section 38M of Massachusetts General Law, elect from their number a chair-person who shall serve a term of one year as an exofficio member of the School Committee. They are subject to the same privileges as other School Committee members and are to be held subject to the same rules except with the ability to vote, and unless permitted to do so by the School Committee to attend Executive Session.

Purpose:

To provide for a meaningful link and to promote a mutual sense of respect and understanding between the student body and the School Committee.

To represent before the School Committee, the attitudes, interests and concerns, both positive and negative, of the student body.

To advise the School Committee and add insight to their deliberations.

To carry to the School Committee and to support proposals and items of concern to the student body, and to initiate, on behalf of the student body and in conjunction with the student government, projects and proposals for presentation to the School Committee.

To inform the student body of the functions and workings of the School Committee. To represent to the School Committee a cross-section of the entire student body.

Regular Responsibilities:

- Be accessible to, and representative of, the entire student body.
- Gather collective sentiment that is representative of the entire student body and present those views to the full Committee.

- Share information among the Committee, staff, and students.
- Contribute to Committee deliberations.
- Communicate with staff and students about student concerns and help develop solutions.
- Collaborate with other student representatives and members of the School Committee.

Ex-Officio Member Responsibilities:

- Attend every Regular Session meeting during their term
- Prepare and present a "Student Report" at every Regular Session that includes, but is not limited to: student events, concerns, recommendations, projects, etc
- Attend Standing Committee and Special/Ad-Hoc Committee meetings to share sentiment of the student body
- Contribute to Committee deliberations where appropriate

Student Advisory Committee Representative Responsibilities:

- Attend Regular Sessions during their term when scheduled, if possible
- Help prepare and present a "Student Report" at every Regular Session that includes,
- but is not limited to: student events, concerns, recommendations, projects, etc.
- Encouraged to attend Standing Committee and Special/Ad-Hoc Committee meetings to share sentiment of their respective student body

Composition:

The Student Advisory Committee shall be composed of one student representative from each of the following schools:

- Claremont Academy
- Doherty Memorial High School
- Gerald Creamer Center
- North High School
- South High Community School
- University Park Campus School
- Worcester Alternative School
- Worcester Technical High School
- The Challenge and Reach Academy
