# 7. Jolo, Inc. dba Hurricane Betty's, 350 Southbridge Street Violation of Rule #14

Pat Scorzelli and Mr. Fitzwilliams, the night manager of the premises, appeared upon behalf of the violation and waived their right to counsel.

Sergeant Needham presented the following.

#### **FEBRUARY 17, 2024**

On February 17, 2024, Sergeant Thomas Needham of the Worcester Police Department was conducting compliance checks when he observed a large number of cars outside Hurricane Betty's.

Sergeant Needham observed that a number of entertainers were still inside the premises after hours and informed the night manager that the process needed to be more efficient and that only employees of the bar can remain on the premises after closing time and only for specific reason.

Sergeant Needham asked about the scanner which was a required device at premises. A condition imposed by the License Commission after violations occurring in March 2022 at Hurricane Betty's. A member of staff walked over to the end of the bar and retrieved what he said was the ID scanning device. The devices' battery was depleted, and staff looked for a power cord and plugged it into the device. Upon plugging the power cord in, the screen eventually lit up and indicated that the battery was completed depleted, and the device would not function until at least a minimal charge for the battery was achieved. Sergeant Needham explained to staff and Joseph O'Grady, the owner, who was on scene, the condition regarding the scanner and they stated they understood the mandate.

#### **JUNE 7, 2024**

On June 7, 2024, Sergeant Needham and Officer Patrick Harrington went to Hurricane Betty's to conduct a follow up visit.

Upon entering the premises, they requested from security personnel where the ID scanner was. Security picked up a device that was hooked up charging and after a short warm up period the device powered on and appeared to be in functioning mode. Sergeant Needham requested security show him the screen that records the ID's that have been scanned. He handed Sergeant Needham the device and the screen indicated that the last ID's scanned were on June 3, 2024.

Sergeant Needham observed the patrons inside the premises and no ID's scans were recorded on June 7, 2024. Scrolling through the history of the device Sergeant Needham observed that there were five scans done on June 3, 2024, three scans done on June 2, 2024, and the next previous scan was done on May 4, 2024.

At this time the night manager arrived on scene and Sergeant Needham and Officer Harrington discussed with him the findings. The night manager stated something to the effect of, "I tell them every night to use the scanner."

The night manager was informed that the incident would be brought before the License Commission.

Mr. Scorzelli stated that he did not know about the two events, and they have talked to security, and they are going to talk to staff to fix it. They have a scanner, and staff are told to use the scanner.

Mr. Fitzwilliams stated that he does run a tight ship, and he does understand that they have to fix the scanner situation.

Mr. Fitzwilliams stated that he has to pay the girls at the end of the night and some nights are busier than others and he needs to know what time they need to be out of the building.

Chair Vigliotti asked if they were denying what Worcester Police present. Mr. Fitzwilliams stated no and it just that girls just waiting to get paid out.

Chair Vigliotti stated that is a big concern to the Commission and that the Commission put a number of conditions from the previous violations at the premises and one of the conditions was that the scanner had to be used.

Sgt. Needham stated that he had concerns as when he conducted surveillance there were many cars in the parking lot and saw many men coming in and out of business. On June 7 when he went to the location there were no scans on the scanner.

Mr. Scorzelli stated that if that what Sgt. Needham said happened it is what happened, and they obviously have internal issues and a scanner issue.

Commissioner Fisher stated that the scanner problem needs to be fixed.

Upon a roll call vote the Commission voted 3-0 that the violation did occur.

Upon a roll call vote the Commission voted 3-0 to issue a ten-day suspension.
