Program Updates (E. Gagne)

A) Workforce Innovation and Opportunity Act

E. Gagne thanked the WIOA youth review team (Robin Hooper and Kim Samia) for their participation in the FY25 proposal review process. An overview of WIOA and FY25 program highlights, youth elements, performance indicators, and proposal content occurred. Youth funding recommendations were presented that prioritize an integrated delivery system that supports qualitative academic and career pathway certificate training programs with attainment of a state recognized credential and outcomes. The review team would like to enter into negotiations and prioritize funding the Fieldstone School, LLC and Youth Opportunities Upheld, Inc. If funding allows, we also recommend the Worcester Community Action Council, Inc. if the agency has the ability to revise their outreach, recruitment and assessment process. The FY25 recommendations were forwarded to all YWIC members for final review and comment by April 16, 2024.

Hearing no comments, the recommendations will proceed to the Board for review and final approval.
