SUBJECT: Elm Park RDA Application for 01-13-2025 Meeting – Description of Work

### 1. Purpose of Proposed Work:

a. DPW and Parks is proposing, by public bid process, to perform renovations to the existing playground at Elm Park.

### 2. Scope of Proposed Work:

- a. Remove and replace existing Poured-in-Place (PIP) unitary safety surfacing, which no longer meets DPW and Parks current standard.
- b. Remove approximately 860 SF of existing adjacent bituminous asphalt pavement and replace with new PIP. The purpose is to connect and unify the five playground areas and allow the installation of the two proposed new saucer swings.
- c. Remove and replace or repair existing playground equipment (saucer swings and composite playground).

#### 3. Schedule:

a. Proposed Work schedule to be completed within 90 days of Award of Contract/Notice to Proceed or by June 01, 2025, whichever is sooner.









## PROPOSED SCOPE OF WORK

Remove and Replace in kind approx. 10,310 SF of existing poured-in-place (PIP) rubber safety surfacing.


> Remove and Dispose of approx. 860 SF of existing bituminous pavement and concrete curb. Install new precast concrete curb and new poured-in-place (PIP) rubber safety surfacing.

Remove and replace play equipment in playground areas (B)(C)(D)(E)(will require ground disturbance for new concrete footing).

Remove and replace play equipment in playground area (will NOT require any ground disturbance).




\*\* TYPICAL DETAIL: PROPOSED PREPARATION AND RENOVATIONS FOR AREAS B,C,D and E





# Perforated Pipe Subdrain (Not in Contract)




